It is hereby stipulated that the present terms and conditions of sale apply exclusively to accommodation providers whose property is on French soil in the Portes du Soleil and who wish to participate in the Multi Pass project in the French-Swiss territory of the Portes du Soleil, as indicated on the website [www.multipass.portesdusoleil.com](http://www.multipass.portesdusoleil.com).

Use of the website [www.multipass.portesdusoleil.com](http://www.multipass.portesdusoleil.com) implies the Client’s express, prior and full acceptance of the terms and conditions of sale that follow. Failure to follow the requirements as laid out in the terms and conditions – and in particular, any case of fraud or attempted fraud, or incident involving payment for an order – may result in the suspension of the client’s access to the service, or the client’s account being blocked, depending on the seriousness of the incident, without prejudice in view of any damages and interest that ADPEPDS may seek. As a consequence, ADPEPDS reserves the right to refuse all orders from a client with whom there is such a dispute.

### Definition

The “**Multi Pass**” is a multi-activity card which allows the holder unlimited access during their holiday to a range of activities located within the French-Swiss Portes du Soleil: mountain lifts for walkers, swimming pools and bathing lakes, tennis courts, ice rinks, holiday trains, mini-golf, cultural venues and public transport. The card also offers reductions on numerous activities with partnering service providers in Portes du Soleil village resorts.

By registering for the Multi Pass, accommodation providers ensure that their guests get the card for free or at a reduced price.

### Registration options

The choice of which card to choose and buy is the accommodation provider’s responsibility.

“**CLASSIC MEMBERSHIP**”: Accommodation providers should declare the total occupancy capacity of their rental property/ies; their registration fee is based on the number of beds.

Guests staying in this accommodation are entitled to the “Multi Pass accommodation provider” card, on sale at mountain lift ticket offices.

**“SEASON MEMBERSHIP”:** Accommodation providers buy the Multi Pass season cards as part of the all-inclusive package for guests. The number of Multi Pass season cards cannot be less than 60% of the total number of beds or rental properties.

Guests staying in this accommodation are entitled to a free “Multi Pass” card, whose price is included in the cost of their accommodation.

## Membership rates

**Classic membership:** Prices are according to the number of beds (total guest capacity).

Registration before 31 May 2022	12 € / bed
Registration between 1 - 30 June 2022	17 € / bed
Registration from 1 July 2022	27 € / bed
From 301 <sup>st</sup> bed to 500 <sup>th</sup> bed	10 € / bed
From 501 <sup>st</sup> bed	8 € / bed

### Prices for holiday centres

Registration before 31 May 2022	10 € / bed
Registration between 1 - 30 June 2022	14 € / bed
Registration from 1 July 2022	23 € / bed

**Season registration:** Prices are according to the number of beds and cannot be less than 60 per cent of total sleeping capacity.

Registration until 30 June 2022	40 € / bed
Registration from 1 July 2022	60 € / bed

Accommodation providers are required to purchase magnetic “hands-free” cards (cost 1€) for their Multi Pass to work.

## Multi Pass prices

**Multi Pass card – when not staying with a Multi Pass partner:** 12 € per day  
80 € for the summer season

**Multi Pass card from a Multi Pass accommodation partner:** 2.50 € per day (minimum purchase 2 days).

**Multi Pass season card from a Multi Pass accommodation partner:** 40 € for all registered partners. Limited to 2 cards per accommodation provider.

**Magnetic “hands-free” card to load the Multi Pass on to:** cost 1 €

Multi Pass is free for children under 5 years old.

## **Cancellations / Withdrawals**

---

Accommodation providers may withdraw from the promotion and request a refund **before** the cards are activated, on the 11 June 2022.

After 11 June 2022, no cancellation or withdrawal or refund is possible, even if the accommodation provider has not rented their property or if their clients do not want the Multi Pass card.

## **Treatment of personal data**

---

Information gathered by ADEPDS to open an account on [www.multipass.portesdusoleil.com](http://www.multipass.portesdusoleil.com) is compulsory and indispensable when activating an account. This data is destined for the sole use of the Portes du Soleil for administrative and commercial purposes.

In conformity with the Data Protection Act from 6 January 1978, all those whose personal information has been collected automatically are entitled to oppose, access, change, correct or delete said information.

## **Applicable law**

---

These General Terms and Conditions of Sale and the operations that result therein are governed by and subject to French law.

All disputes relating to the registration procedure in line with the present terms and conditions and for which no amicable settlement has been reached, shall be decided by the Thonon Les Bains courthouse, which has jurisdiction in common law matters.
